## **Summary Statement**

Having been trained as a cultural anthropologist, at present I am with the Department of Sociology, South Asian University, New Delhi. Prior to that, I served the Department of Sociology at the University of Colombo for a period of 19 years. In my teaching career, I have straddled subject areas that are considered both Sociology and Anthropology in the general parlance, despite the debates that surround these titles and disciplinary divides. In that sense, I have been fortunate enough to be able to cross boundaries and draw from developments in these disciplines quite liberally in both my own intellectual pursuits and in my endeavors to teach and guide students.

My research interests are varied and have evolved over the years. Broadly speaking, I am interested in contemporary social theory with an emphasis on the idea of culture and its politics. More specifically, I focus on the rhetoric of 'development', politics of civil society organizations in governance and democratization and issues of devolution of power in Sri Lanka, and problems of urbanization, space and dynamics of urban experience in South Asia/ Sri Lanka. I have also had an enduring interest in cross-cultural communication, the role of education and socialization in eradicating or promoting sectarian conflicts, role of teachers and dynamics of teacher training in multi-ethnic and multi-cultural societies within my broader interest in the politics of education in multi-ethnic societies. I have also paid attention to the problems and politics of refugee proliferation, political violence, nationalism and post-violence trauma, transformation and politicization of religion in Sri Lanka and Nepal and politics of memory, interpretation of culture and the politics of visual arts, and the significance of biased interpretations of history and myth. My research interests have enabled me to work in Sri Lanka, USA, Cambodia, Pakistan and Nepal. I have written extensively and published both locally and internationally in the English and Sinhala languages while some of my work has also been published in Tamil, Japanese and Spanish. At present, I am working on a book on the politics of violence and memory in Sri Lanka.

The courses I have taught at PhD, MA, MPhil and BA levels *include Social Theory, Society and Modes of Thinking* (MPhil/PhD); *Photography and Method in Sociology and Social Anthropology* (MPhil/PhD) *Critique of Everyday Culture, Sociology of the Arts and the Politics of Social Transformation (MA); Sociology of South Asia (MA); South Asian Ethnography (BA); Structure of Sri Lankan Society (BA); Sociology of Religion (BA); Sociology of Political Violence(BA); Advanced Sociological Theory (BA); Sociology of Sports and Leisure (BA).* The dissertation and thesis projects I have supervised cover the gamut of my research interests and have included some areas that are pioneering and challenging to the advancement of the discipline.

An interest in photography, poetry, blogging, art, music and journalism has kept me in touch with both my own creative drives as well as the changing world of thought and expression. These worlds constantly merge and split, paving the way for growth and fulfillment.
